The scope of this notice and authorization is all-encompassing, however, allowing the Zephyr Point Presbyterian Conference Center to obtain from any outside organization all manner of consumer reports and investigative consumer reports now and, if you are selected, throughout your affiliation with Zephyr Point Presbyterian Conference Center to the extent permitted by law. As a result, you should carefully consider whether to exercise your right to request disclosure of the nature and scope of any investigative consumer report.
